## Annual ACCESS Senior Shoebox Project Brings Gifts of Cheer to Seniors

**Medford, November 5:** For over 30 years, during the holiday season, the annual ACCESS Senior Shoebox Project brings gifts of cheer and care to seniors, people with disabilities, and people who are homebound in Jackson County. Donors and volunteers can fill and wrap shoeboxes with a variety of gift items from the Senior Shoebox Wishlist, which are then hand-delivered before Christmas. This year we have seen an increase in need and a surge in nominations.

The annual ACCESS Senior Shoebox Project is accepting wrapped gift boxes filled with fun and usable gifts now through Friday, November 21. Examples of the most needed items include hats, scarves, socks, potholders, large handle can openers, pillboxes, toothbrushes, jar grippers/openers, card games, crossword puzzles, etc. **We ask that the box lids and bottoms be wrapped separately, so we may add a holiday greeting from ACCESS to each box.** The shoeboxes will be delivered by volunteers between December 1<sup>st</sup> and 5<sup>th</sup>.

“Recipients and donors alike look forward to this program every year. The shoebox gift brings so much joy to seniors throughout our community, who might not otherwise receive a gift for the holidays,” says Kellie Battaglia, Chief Advancement Officer.
